To qualify for this discount, depending on the year of the vehicle, the mileage must exceed the following limits:

2008 ..... 65,000 miles	2007 ..... 75,000 miles	2006 ..... 90,000 miles	2005 ..... 100,000 miles
2004 and older ..... 115,000 miles			

A certified inspection station or a representative from the Assessor's Office must verify the mileage. The owner must sign the front certifying that the mileage is true and actual as of July 1, 2012. Your 2013 tax year personal property assessment report on the other side must also be completed and returned by October 1, 2012.
